Ralos New Energies AG (formerly BGI EcoTech AG) specialises in the growth market of regenerative energies, particularly photovoltaics. The company, which was founded in 1990, is a management holding company. With subsidiaries and distributors in Germany, Austria, Spain, Italy, Canada, Czech Republic and Dubai, Ralos is represented in the most important and potentially fastest growing international markets. Ralos Vertriebs GmbH, one of Europe's leading systems solutions providers in the field of photovoltaics, is the company's most important holding.

The company develops, plans, builds and operates innovative photovoltaics plants, ranging from private solar electricity systems to large-scale high-output plants of all sizes for industrial clients. In the financial year 2008, Ralos employed more than 125 people and generated turnover of around € 130 million. In the medium term, the group, which is listed in the entry standard of Frankfurt Stock Exchange, aims to achieve turnover of € 500 million.

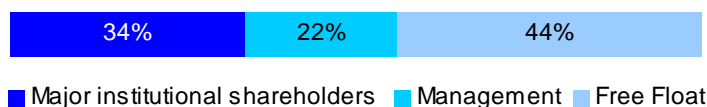

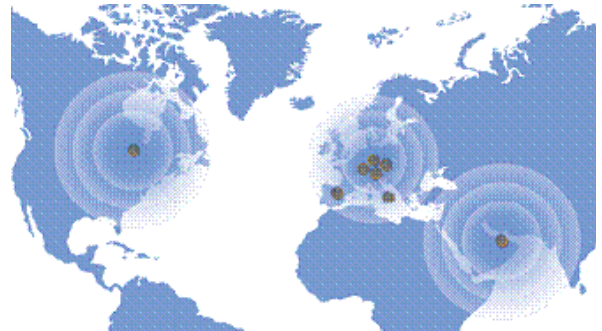

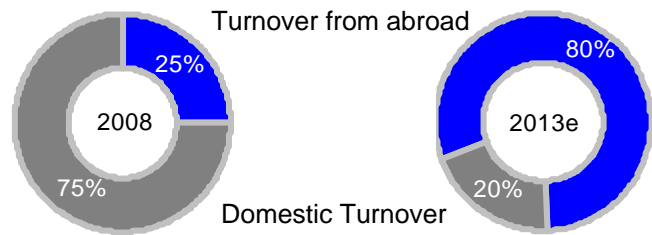
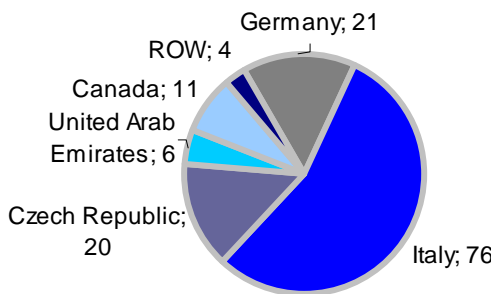
